- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2077-10-21 13:00 hours at the Office of Mikwakhola Rural Municipality, Taplejung. Bids must be valid for a period of 90 days after bid opening. Bid security amount must be as per above table and shall be valid for 30 days beyond the bid validity period.
